

Joint-Secretary	Rs. 10,000/- (Rupees Ten thousand only)
Assistant Secretary	Rs. 8,000/- (Rupees Eight thousand only)
Assistant Secretary (Library)	Rs. 7,000/- (Rupees Seven thousand only)
Member Executive Body	Rs. 5,000/- (Rupees Five thousand only)



Important instructions for the candidates filing nomination paper.

1. Candidate is to fill up the Form by hand.
2. The original money receipts granted at the time of issuing the Nomination Paper and Nomination Fees shall be attached with the nomination paper.
3. Candidates who prefer to file more than one nomination paper shall have to attach photo copy of the receipt of nomination fees and original receipt of the nomination paper.
4. Candidate, proposer & seconder has to submit self attested copy of their identity cards issued by Orissa State Bar Council or the Orissa High Court Bar Association.
5. In order to avoid any confusion or ambiguity candidates are requested to fill up the Nomination form by hand in BLOCK CAPITAL letters and avoid overwriting, whitener etc.
6. Candidate has to give an undertaking along with the nomination paper, as provided separately.
